

**PRIVACY NOTICE REGARDING THE PROSESSING OF THE

Hereby Privacy Notice Regarding the Processing of Personal Data, is valid for the data of the relevant data subjects specified in the upper right box, held by the Enka Spor Eğitim ve Sosyal Yardım Vakfı İktisadi İşletmesi and Enka Spor Kulübü as the data controller.

Our Sports Schools are organized by Enka Spor Eğitim ve Sosyal Yardım Vakfı İktisadi İşletmesi Özel ENKA Okulları (ENKA Schools), in cooperation with the ENKA Vakfı (ENKA Foundation) and ENKA Spor Kulübü (ENKA Sports Club).

**1. WHY IS THIS NOTICE BEING SENT?**

As ENKA SPOR EĞİTİM VE SOSYAL YARDIM VAKFI İKTİSADİ İŞLETMESİ, ENKA SPOR KULÜBÜ ("ENKA", "Enterprise") we take into account the security of your personal data, including all persons who benefit from our services as a Enterprise, and all kinds of documents belonging to all persons associated with our Enterprise. We attach great importance to the processing and preservation of personal data, firstly in accordance with the Constitution and then in accordance with the General Data Protection Regulation ("GDPR"). In this context, in accordance with the General Data Protection Regulation ("GDPR"), Enka Spor Eğitim ve Sosyal Yardım Vakfı İktisadi İşletmesi, as the Data Controller, will process your personal information within the framework of different channels and legal grounds, as explained below, your personal data is provided, processed within the framework such as recording and storage, transferred to third parties where the legislation allows, and all kinds of administrative and technical measures are taken to ensure the security of the data in question and to prevent access by unauthorized persons.

**4. WHO WE SHARE YOUR PERSONAL DATA WITH AND ON WHAT PURPOSE?**

## 7. YOUR RIGHTS BASED ON GDPR

Based on the General Data Protection Regulation Art. 13 et seq. to learn about the rights you have over your personal data and to exercise your rights specified in the Personal Data Protection and Processing Policy, you can consult our Enterprise.

By applying to our Enterprise, you have;

- a) Right to be informed about what personal data is collected, why, who is collecting data, for how long, how you can file a complaint and if there is data sharing involved,
- b) Right to submit an access request and attain information from the organization about whether your personal information is being processed,
- c) Right to rectification meaning individuals can ask our Enterprise to update any inaccurate information,
- ç) Right to be forgotten meaning right to erasure,
- d) Right to restrict processing meaning individuals can request to limit the processing of the personal data,
- e) Right to data portability meaning individuals can obtain personal data they have previously provided for the organization structured, commonly used, and machine-readable format,
- f) Right to object processing meaning individuals can object to processing personal data at any time.

If you submit your requests regarding your rights listed above to our Enterprise, our Enterprise will finalize the request free of charge within thirty days at the latest, depending on the nature of the request.

In your application;

- If you are making the application in your own name, your name and surname, and your signature if the application is written,
- For citizens of the Republic of Turkey, your identification number; if you are a foreigner; your nationality, passport number or identification number, if any,
- Your residence or workplace address subject to notification,
- Your notification e-mail address, telephone and fax number, if any,
- It is mandatory to include the subject of your request, and if any, information and documents regarding the subject must be added to the application.

You can submit your requests through the communication channels on our website, [bilgi@enkaspor.com](mailto:bilgi@enkaspor.com), using the email address previously provided and registered in our system.

In order to ensure the proper identification for your request, it is essential that all requested information and documents enabling identification are provided accurately and completely. Failure to provide the requested information and documents may result in disruptions in the thorough and qualified conduct of investigations by our Enterprise regarding your request. Therefore, it is imperative that your application includes all the required information and documents necessary for identification, according to the nature of your request. Please be advised that our Enterprise reserves its legal rights in such cases.

## 8. PRECAUTIONS FOR PROTECTING YOUR PERSONAL DATA

Protecting your personal data is an important issue for our Enterprise. Our Enterprise takes the necessary technical and administrative measures to protect personal data against unauthorized access or loss, misuse, disclosure, alteration or destruction of this information. Our Enterprise is committed to keeping your personal data confidential, to take all necessary technical and administrative measures to ensure confidentiality and security, and to show due care.

Although our Enterprise takes the necessary information security measures, if personal data is damaged or obtained by third parties as a result of attacks on the website and system, our Enterprise will immediately notify you and the Personal Data Protection Authority.

## 9. CORRECT AND CURRENT STORAGE OF YOUR PERSONAL DATA
